

VISITOR ACKNOWLEDGEMENT OF RISK

In consideration for receiving and accepting the services of Colorado River Discovery, LLC, its principals, directors, owners, officers, members, managers, agents, employees, independent contractors and all other persons or entities associated with the business (hereinafter collectively referred to as "CRD"), I hereby agree as follows:

Although CRD has taken reasonable steps to provide me with appropriate equipment and skilled guides so that I can enjoy an activity in which I may not be skilled, CRD has informed me that this activity has inherent risks that cannot be eliminated. I understand that these inherent risks may result in loss of or damage to my personal property, accidental injury to me or any minor children for whom I am responsible and in extreme cases permanent trauma or death.

The following describes some, but not all, of the risks:

- Boarding areas and the boats may be slippery, especially when wet. I may slip or fall on loading docks, boarding steps, or when getting on and off, or when moving around the boats.
- I am aware that I may encounter very cold water, or that I may unintentionally fall overboard.
- Exposure to the natural elements can be uncomfortable and/or harmful. I am aware that this exposure could cause severe sunburn, dehydration, hypothermia, hyponatremia, heat stroke and heat exhaustion.
- Exposure to insects, poisonous reptiles and spiders, wild animals and poisonous plants can likewise be uncomfortable or harmful. I am aware that this exposure may result in insect bites, or bites from mammals or reptiles or other fauna.
- I understand that I will be traveling by bus to the base of Glen Canyon Dam and that the parking lot where I will get off the bus is located directly under a high bridge and highway. Rocks, debris or other objects may fall and hit me.
- I understand that I will be on a boat for several hours and will not have immediate access to medical facilities.
- I am electing to participate in a physical activity outdoors and near water. As with any such physical activity, there is the risk that an accident may occur that results in physical injury to me such as sprained or twisted joints, bruises, scrapes, cuts, lacerations, bone fractures, injuries sustained from falls or from fellow visitors, paralysis, drowning, and injuries or death resulting from rock fall.

I understand that the description of these inherent risks is not complete and that other unknown or unanticipated inherent risks may result in my injury or death, or the injury or death of minor children in my care. My participation in this activity is purely voluntary. I elect to participate in spite of and with full knowledge of the inherent risks.

I assume full responsibility for any loss or injury to myself and all minor children in my care relating to the activity, whether sustained during the activity or not. I acknowledge that I have been given the opportunity by CRD or its assignees, to ask questions regarding the nature and physical demands of this activity and the risks. I certify that I understand the risks and am fully capable of participating in this activity. I acknowledge that I am responsible for my own safety, the safety of minor children in my care and the safety of fellow visitors around me. I expressly agree that this Acknowledgement of Risk shall be governed by the law of the State of Arizona and that the assumption of risk is intended to be as broad and inclusive as permitted by the law of the State of Arizona and that if any portion thereof is held invalid, it is agreed that the balance shall continue in full legal force and effect. Any legal action relating to this agreement or the activities discussed herein shall be decided solely and exclusively by State or Federal courts located in Coconino County, Arizona.

I acknowledge that I have been given the opportunity by CRD or its assignees, to ask questions regarding any aspect of this Acknowledgement of Risk. By signing below, I acknowledge that I have carefully and completely read and fully understand all aspects of this agreement and voluntarily agree to all of the terms and conditions stated in this document and that in doing so have not relied upon any oral representations, statements or inducements apart from statements expressly made herein. This agreement shall be effective and binding upon me, my heirs, assigns, estate, and all members of my family, including minor children.
